# Rubik's Cube Association of Stanford-Constitution <br> (last modified on $1 / 21 / 08$ by Timothy Wong) 

## Article I - Name of Organization

This organization will be known as the Rubik's Cube Association of Stanford.

## Article II - Statement of Purpose

-To organize and host "speedcubing" competitions.
-To provide resources and a supportive community for those who wish to learn how to solve the cube and for those interested in improving their solving skills.
-To promote the spread of Rubik's Cubing as both a recreational hobby and as a competitive sport.

## Article III - Eligibility for Membership

Membership will be open to all registered Stanford students.
In addition, members must demonstrate interest in one or more aspects of Rubik's Cubes and must be supportive of the community of Rubik's Cubers at Stanford. Members will be expected to assist in organizing, planning, and running speedcubing competitions.

## Article IV - Officers

## A. Titles and Responsibilites

1) President

The president shall be responsible for the organization as a whole and will be in charge of all major decisions pertaining to the organization. The president will be the main representative of the organization and is required to attend any and all speedcubing competitions.
2) Financial Officer

The financial officer shall be responsible for managing the group's monetary funds through the ASSU banking service. The financial officer will also be held responsible for the acquisition, distribution, and management of purchased speedcubing equipment.

## 3) Calendar Administrator

The calendar administrator shall be responsible for registering speedcubing competitions on Events at Stanford and selecting dates for competitions that do not conflict with major campus events. The calendar administrator must successfully complete the online training at http://events.stanford.edu/training in order to register events.
4) Social Chair

The social chair shall be responsible for advertising the group itself as well as the speedcubing competitions that it hosts.

## B. Election and Removal Process

There are no criteria for candidacy other than membership in the organization and commitment to the position.
Officers shall be elected through a written ballot, where winners are determined by simple majority.

In the event where one or more officers resign from their positions due to extenuating circumstances, an election shall be held immediately according to the standard procedure. In the event where one or more officers is deemed to be unfit for their position due to demonstrated neglect of that position's responsibilities, a recall election may be held to replace them with another member. This will require a two-thirds majority vote by written ballot.

## C. Length of Term

The length of term for elected officers shall be one academic year. Elections will be held at the beginning of the winter quarter.

## Article V - Sustainability

The organization, under the supervision of the Social Chair, shall take measures to advertise itself and recruit new members for sustainability purposes. The group will utilize the facebook network as well as Stanford mailing lists and word of mouth to promote the group as well as its competitions.

## Article VI - Dissolution of Organization

If the organization becomes defunct, all monetary funds will be transferred to the Associated Students of Stanford University (ASSU). Any and all miscellaneous equipment and property should be sold, auctioned, and/or donated.

## Article VII - Procedure to Amend Constitution

Any proposed amendments to this constitution must be approved by a two-thirds majority vote before taking effect.
